DLDA reserves the right to reject any proposal if the presentation is assessed not remarkable by tender committee after approval of vice chairperson of DLDA.

Other Party shall first attempt to resolve such dispute through friendly consultation. If the dispute is not resolved within 30 days from date of receipt of written notice then any party may issue a notice of reference invoking resolution of disputes through arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be conducted by a sole arbitrator that may be appointed with the consent of both Parties to such dispute. If there is no agreement among the Parties on the identity or appointment of such sole arbitrator within 30 days of issue notice of reference, then the arbitral proceedings will be conducted by a panel of three arbitrators, one arbitrator to be appointed by the DLDA and the other appointed by the Consultant and the third arbitrator to be mutually appointed by the two arbitrators so appointed in accordance with the provisions of the Arbitration and Conciliation Act 1996. Arbitration proceedings shall be conducted in and the award shall be made in English language. Arbitration proceedings shall be conducted at Nainital (U.K.)

The arbitration award shall be final and binding on the Parties, and the Parties agree to be bound thereby and to act accordingly,
